# 3. WHAT WE DO WITH IT

Your personal data is processed in Lisbon, Rua do Ferragial 3/ RC, 1200-182 Lisbon, located in Portugal. Hosting and storage of your data takes place in Google which is located in Germany.

No third-party providers have access to your data, unless specifically required by law.



### 4. HOW LONG WE KEEP IT

Under Portuguese law, we are required to keep your documents for 6 years according to the Data Retention Policy. After this period, your personal data will be irreversibly destroyed. Any personal data held by us for marketing and service update notifications will be kept by us until such time that you notify us that you no longer wish to receive this information. ## 5. WHAT ARE YOUR RIGHTS?

Should you believe that any personal data we hold on you is incorrect or incomplete, you have the ability to request to see this information, rectify it or have it deleted. In addition, you have the right to request the restriction of processing, the right to object to processing, the right to data portability, as well as the right to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
